

Clearing away undergrowth

An intelligent action
A legal obligation

Why clear away undergrowth ?

Clearing away the undergrowth on the land surrounding your home is the best protection for yourself and your possessions :

- It retards the spread of the fire.
- It reduces the force of the fire, which in turn reduces gas and heat emissions.
- It prevents flames from reaching the flammable parts of your premises.

Clearing away undergrowth protects YOU

- Fire fighters can intervene more effectively and with less risk when a property has been cleared of undergrowth.
- When a fire reaches a zone that has been cleared, it reduces in intensity due to the lack of combustibles.
- You are safer in the confines of your house.

Clearing away undergrowth protects our forests

- It limits the chances of an accidental fire starting on your property.

The trees in my garden will not catch alight ... FALSE !

A fierce fire, fanned by the wind, dries up and ignites all vegetation without discrimination ... even olive trees !

Clearing away undergrowth : A Legal Obligation

Article 32 of the Law of Orientation on Forests of 9 July 2001 defines clearing away of undergrowth obligatory "The operations of which the objective is to reduce the intensity and to limit the spread of fires by reducing combustible vegetation, thereby guaranteeing a break in the continuity of vegetation".

The Commissioner of the Var has detailed the regulation of the obligatory clearing away of undergrowth (www.var.pref.gouv.fr).

What does this concern ? All land and constructions less than 200 metres from the forest (see details given by the P.O.S. and the P.L.U. on the DDAF site : www.cdig-var.org)

Having correctly respected the rules of clearing away undergrowth, there are still a few precautions to take in order to protect your house.

- Most often, your premises will catch alight only if the fire penetrates the interior.

Precautions to take

- Opt for wooden shutters instead of plastic.
- Do not install PVC drainpipes.
- Do not have big bay windows without wooden protection.
- Clean your roof every year to eliminate leaves and pine needles.
- Avoid stacking wood against the house.
- Assure that there are no unused gas bottles or flammable liquids lying around that could explode in case of fire.
- Opt of underground fuel tanks.



In case of short term absence Shopping, the beach, a walk ...

- If a fire starts in the vicinity, you risk not being able to return to your house.
- Close all windows, doors and shutters before leaving home, even if it is only for a few hours.
- Avoid locking your gate in order to allow access by the emergency services.



If the fire moves in the direction of your house ... If your house is a permanent structure and has been correctly cleared of undergrowth, it is your best form of protection.

Unless otherwise advised by the authorities

- Assemble your family and pets in your house.
- Open the gate of your property to allow access to fire fighters.
- Close all shutters.
- Block all openings with wet towels, sheets, ...
- Close the trap door of the fire place.
- Wear cotton clothing that covers your whole body (no synthetic fabrics).
- Keep the following items handy: leather gloves, a cap, glasses, a scarf and leather ankle or knee length shoes if possible.
- If you have a swimming pool that uses a petrol-operated pump, take the pump indoors, as well as the pipes and the fuel can.
- Place gas bottles in the swimming pool or in a bath filled with water.
- Take in plastic garden furniture.
- Shelter cars, with windows closed, in the opposite direction of the wind, against the house.



The fire passes by very quickly, a few minutes or more.

- After the fire has passed through your property, use your pool pump to soak everything flammable around your house.
- Pay special attention to the roof and the roof structure.
- Extinguish residual fires by watering them abundantly and by turning over ashes where coals could still be smoldering.
- Check to see if your neighbours need help.
